SUBJECT: Submission of Proof of Publication

DATE : 10 June 2021

Please be informed that Section 5 of Department Order 221, series of 2021 requires the employer to publish job vacancy being applied for by the foreign national in a newspaper of general circulation.

Submission of proof of publication of job vacancy in a newspaper for the online application should contain the name of newspaper, date of publication and number of job vacancies. The following proofs shall be accepted:

- 1. Affidavit of publication issued by the publisher; and
- 2. News clippings containing the date of publication and name of newspaper where it is published. (see attached sample)

Only the positions contained in the proof of publication being submitted to this Office will be accepted when filing the application for the issuance of Alien Employment Permit.

We reiterate that pursuant to Advisory 04, series 2021 dated 14 May 2021 duly signed by Secretary Silvestre H. Bello III, "publication of vacancy/ies shall be made at least fifteen (15) calendar days prior to the application of AEP, and shall be valid and effective within thirty (30) days from the date of publication in a newspaper of general circulation."
