

Argentina: ENACOM desregula los precios de los Servicios TIC

En breve

Mediante Resolución N° 13/2024 ("**Resolución**"), el Ente Nacional de Comunicaciones (ENACOM) derogó una serie de resoluciones que regulaban la fijación de precios de servicios de tecnologías de la información y comunicación ("**Servicios TIC**").

En profundidad

Mediante **Decreto N° 302/2024 el Poder Ejecutivo Nacional desreguló los Servicios TIC**, modificando la Ley Argentina Digital N° 27.078 y derogando el Decreto N° 690/2020, lo que implicó la eliminación de la potestad de ENACOM para regular los precios. La Resolución busca promover la expansión de los servicios, fomentando un entorno más competitivo en la industria de las TIC.

A fin de reglamentar la eliminación de dicha potestad la Resolución derogó las siguientes resoluciones que reglamentaban la regulación de precios de los Servicios TIC, incluyendo servicios de telefonía, internet y televisión por cable: ENACOM N° 1.466/2020, N° 27/2021 (ratificada por Resolución ENACOM N° 170/2021), N° 28/2021 (ratificada por Resolución ENACOM N° 163/2021), N° 203/2021, N° 204/2021 (ratificada por Resolución ENACOM N° 588/2021), N° 862/2021, N° 2.187/2021 (ratificada por Resolución ENACOM N° 275/2022), N° 725/2022 (ratificada por Resolución ENACOM N° 1.174/2022), N° 1.754/2022, N° 2.393/2022, N° 2.494/2022 (ratificada por Resolución ENACOM N° 409/2023), N° 557/2023, y N° 323/2021.
