APPENDIX C

MAXIMUM VALUES FOR NON-EMERGENT SERVICE FEES

The fees for services rendered by fire brigades and civil emergency management, in nonemergency circumstances, shall be:

Baker McKenzie.

- 1. Where it is necessary to consider the metric surface area of the building or space, either for a safety inspection in terms of prevention, protection against fires and other claims, for the participation of the Technical Room (ST), the evaluation of the fire project, technical reports, expert opinions and inspection for shows or public attractions, the fee will be: up to an amount in bolivars equivalent to 0.10 times the official exchange rate of the currency of highest value published by the Central Bank of Venezuela per square meter of extension or area. The taxable minimum will be five times the official exchange rate of the currency of the highest value published by the Central Bank of Venezuela.
- 2. Fee for the issuance of documents or certificates for investigations of fire events or other incidents: up to an amount in bolivars equivalent to 30 times the official exchange rate of the currency of the highest value published by the Central Bank of Venezuela.
- 3. For the prevention guard service to any natural or legal person who requests it, for the purpose of civil servants carrying out security work in terms of prevention and protection against fires and other accidents, is subject to the payment of a fee, according to the following table:

Description of team with officials	TCMD/HOUR
Ambulance	60
Fire suppression vehicle	120
Special vehicle	150
Other vehicle type	60

- 4. For the investigation of fires and other accidents in vehicles and other property, the fee will be: up to an amount in bolivars equivalent to 0.05 times the official exchange rate of the currency of the highest value published by the Central Bank of Venezuela for each kilogram of the vehicle expressed in its official document issued by the ministry with competence in land transit or the weight of the movable property in question.
- 5. For consulting, training or training services in the field of pre-hospital emergencies, rescue, fire prevention and investigation, analysis, control and evaluation of risks, hazardous substances or materials and any matter related to their area of specialty: up to an amount in bolivars equivalent to five times the official exchange rate of the currency of the highest value published by the Central Bank of Venezuela per hour of service of each participating staff member.
