Mediante la Resolución, publicada en el Boletín Oficial el 02/02/24, la AAIP actualizó el modelo de cartel que identifica las zonas videovigiladas.

El cartel alerta sobre la recolección de imágenes digitales e incluye un código QR e información para que los titulares de datos personales puedan ejercer sus derechos.

El código QR redirige al sitio de la AAIP, que incluye información en materia de protección de datos personales y un buscador para conocer las bases de datos que se encuentran registradas y sus responsables, entre otras cosas.
