

Venezuela: Decreto prorroga las dispensas de Regímenes Legales para la exportación hasta el 9 de junio de 2023

El Ejecutivo Nacional emitió el Decreto No. 4.766 el 9 de enero de 2023, en el cual establece una prórroga de las dispensas de Regímenes Legales para la exportación hasta el 9 de junio de 2023 ("**Decreto**")¹. Dichas dispensas fueron establecidas el 9 de junio de 2021 mediante el Decreto No. 4.525², que fue prorrogado hasta junio 2022.

El Decreto estableció su vigencia a partir del 9 de diciembre de 2022, teniendo efecto retroactivo.
