

Venezuela: Customs Tariff Schedule updated

In brief

On 29 December 2022, the National Executive issued Decree No. 4,758 ("**Decree**"),¹ which adopts the legal regime of goods and the Common Customs Tariff Schedule of the States Parties of MERCOSUR (NCM) ("**Tariff**")².

The Decree entered into force on 3 January 2023, five days after its publication on 29 December 2022.

The Decree does not repeal the reforms of the Tariff established in Decrees Nos. 4,111, 4,684, 4,728 and 4,734 of 5 February 2020, 2 May 2022, 23 August 2022 and 2 September 2022, respectively.

Relevant amendments of the Tariff

1. **Amendment of column 5 of article 37 of the Tariff.** The Decree modified the legal regime for import applicable to subheading 2903.71.00.00 (chlorodifluoromethane), making Legal Regime 10 (Permit from the Ministry with competence in Environmental matters) applicable instead of Legal Regime 1 (Import or Export Prohibited).
2. **Modification of subheadings in article 37 of the Tariff.** The Decree modified the description of goods (column 2), the Ad Valorem Tariff of the Common External Tariff (AEC) (column 4), the legal regime for import (column 5) and the legal regime for export (column 6) of article 37 of the Tariff, for several subheadings. 3. **Incorporation of a new subchapter on goods imported by the State.** The Decree added a new subchapter identified with number IV relating to "Goods Imported by Public Administration Bodies or Entities," in chapter 98 of article 37 of the Tariff.
4. **Amendment of column 4 of article 37 of the Tariff.** The Decree modified column 4 of article 37 of the Tariff (AEC), but only the subheadings indicated below. Such AEC will be applied preferentially and immediately with respect to column 3 of said article.
