

Argentina ratificó el Convenio 108+ en materia de privacidad y protección de datos personales

El 17 de abril de 2023 Argentina se convirtió en el país N° 23 en ratificar el Convenio 108+, el que tiene por objeto proteger la privacidad de los individuos contra posibles abusos en el tratamiento de sus datos personales.

La ratificación por Argentina del Convenio 108+ se dio en el marco del Simposio sobre Privacidad 2023 celebrado en Venecia entre el 17 y el 21 de abril. Durante la ceremonia inaugural, que incluyó un programa dedicado al Convenio 108+, la directora de la Agencia de Acceso a la Información Pública, Beatriz de Anchorena, depositó los documentos de ratificación en presencia del secretario general adjunto del Consejo de Europa, Bjørn Berge.

La ratificación de Argentina ayuda a acercarse al número de Estados que se requieren para que el Convenio 108+ entre en vigencia el 11 de octubre de 2023. El número requerido es de 38.
